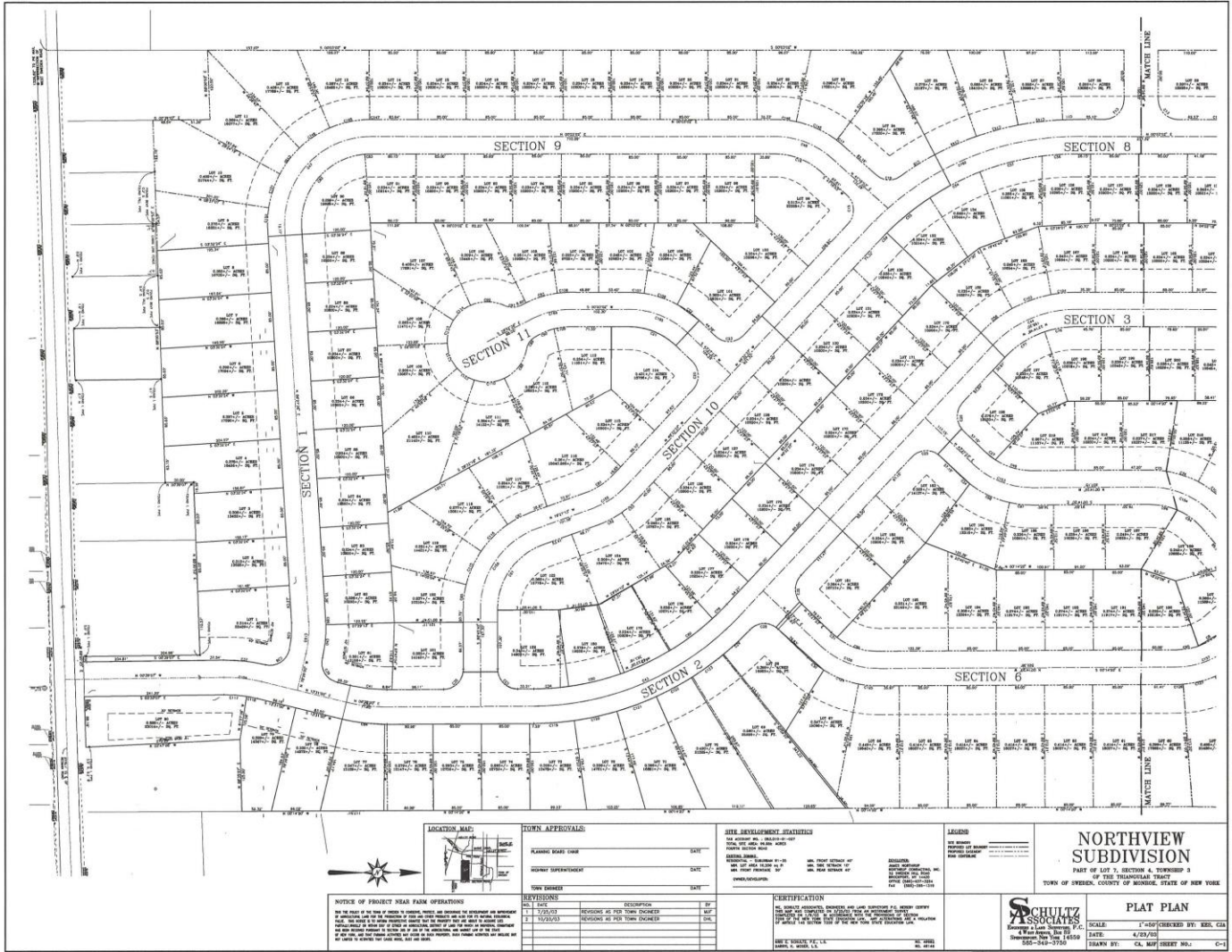

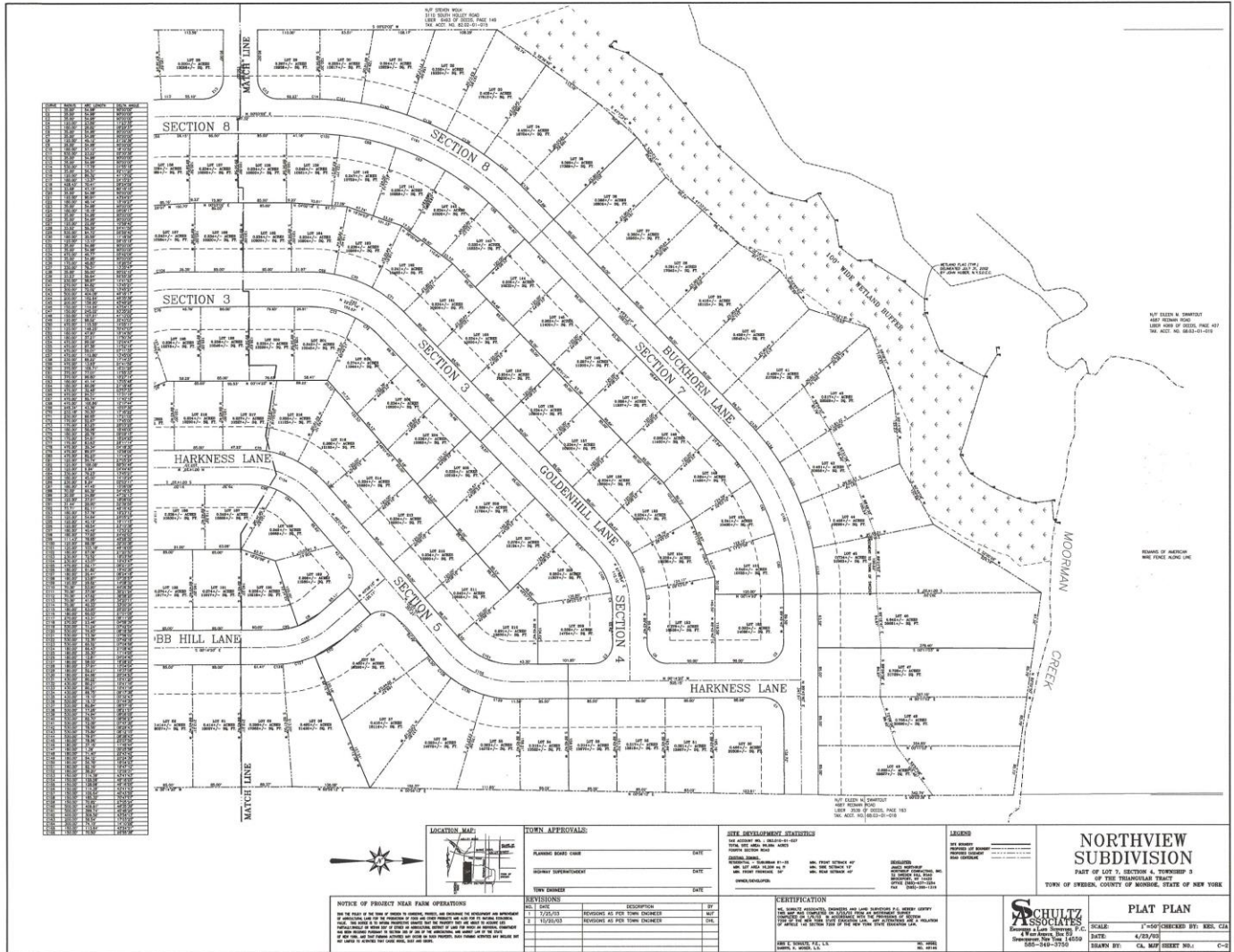

1. **PROPERTY DESCRIPTION:** Property located in the Town of Sweden, County of Monroe, State of New York, known as Northview Subdivision and consisting of approximately 84.06 acres including all buildings, and any other improvements and all rights which the Seller has in the property, subject to all rights to streets, roads, highways, driveways, easements, leases, and rights-of-way:

  - b. Property sells as per deed description.
  - c. The Property, including all improvements, fixtures, appliances, etc, is sold "AS IS" without exception. Seller makes no warranties, expressed or implied, regarding the same.
